The selection process

Applications for summer internships should be received by Friday 8th March 2024. Selected applicants will be e-mailed to arrange a short video interview on the basis of which you may be invited for a full interview at Corbett Keeling. Successful applicants will be offered an internship by Friday 26th April at the latest.

Applicants should be in either their second or final year of university or a recent graduate and be available for a minimum of 6 weeks. Competition for internships at Corbett Keeling is fierce. Successful applicants are likely to have a minimum of A*AA at A level and to be at a Russell Group university. They are also likely to have had some sort of previous work experience, whether it be in hospitality, working in a shop or anything which demonstrates they have some drive and willingness to work hard.
